The post holder should be able to demonstrate the following **essential criteria**:

- Degree level qualification in Physiotherapy (BSc/ Pre-reg MSc)
- Registered with the Health and Care Professionals Council (HCPC) and the Chartered Society of Physiotherapy (CSP).
- Keen interest in Musculoskeletal Physiotherapy including the assessment and treatment of all conditions in all age groups (7years olds+) and in all levels of sporting ability
- Further interest in spinal pain and sporting injuries
- An excellent communicator and an ability to use manual therapy to supplement an exercise rehabilitation approach
- Experienced (2 years' experience within the UK) in assessing and treating a wide range of musculoskeletal conditions (recent graduates will be considered if motivated and have evidence of relevant experience)
- Evidence of CPD maintenance
- Professional approach when dealing with the public (in particular when dealing with client confidentiality)
- Trustworthy, especially when dealing with financial matters related to the clinic and clients
- Must be friendly and chatty and be able to put clients at ease
- Good communicator and able to work within a team environment
